LIGHT LEVERAGE, BIG OPPORTUNITIES

Horizons Enhanced Equal Weight Canadian Banks Covered Call ETF (BKCL) is a covered call ETF that gives investors lightly levered exposure to the six largest Canadian banks in an equal weight portfolio and uses a covered call strategy to help generate additional income on the portfolio.

Canada's Big Six Banks – Toronto-Dominion Bank (TD), Royal Bank of Canada (RBC), Bank of Montreal (BMO), Bank of Nova Scotia (BNS), Canadian Imperial Bank of Commerce (CIBC), and National Bank of Canada (NBC) – have traditionally been a source of stable dividend income for investors in one of the country's largest sectors. A covered call strategy is a way to potentially further increase that income stream through the use of covered calls that can help generate a premium. With 1.25x leverage, BKCL can potentially magnify performance.

INVESTMENT OBJECTIVE:

BKCL seeks to provide, to the extent reasonably possible and net of expenses: (a) exposure to the performance of an index of equalweighted equity securities of diversified Canadian banks , the Solactive Equal Weight Canada Banks Index (the "Underlying Index"); and (b) high monthly distributions of dividend and call option income. To generate income, BKCL will be exposed to a dynamic covered call option writing program.

BKCL will also employ leverage through cash borrowing and will generally endeavour to maintain a leverage ratio of approximately 125%.

Monthly Income: It is anticipated that BKCL will make distributions to its unit holders on a monthly basis.



Canadian Big Six Bank Exposure: As one of Canada's largest economic sectors, the Canadian Big Six Banks have traditionally offered a stable bastion within the broader Canadian equity landscape.



The Covered Call Advantage + Leverage: BKCL's Underlying ETF (Horizons Equal Weight Canadian Bank Covered Call ETF) uses a dynamic call writing approach, which seeks to generate income and reduce downside risk. BKCL employs 1.25x leverage, which can potentially magnify performance, relative to the performance of the Underlying Index.



Call Premium Taxation: Call premiums generated by BKCL's covered call strategy are taxed as capital gains, which is traditionally considered the most efficient form of investment taxation for investors.

HOW BKCL WORKS

The mechanics behind how BKCL works are relatively simple. BCKL invests in the Horizons Equal Weight Canadian Bank Covered Call ETF (the "Underlying ETF" or "BKCC"). BKCC seeks to provide, to the extent possible and net of expenses: (a) exposure to the performance of an index of equal-weighted equity securities of diversified Canadian banks, the Underlying Index; and (b) monthly distributions of dividend and call option income. To mitigate downside risk and generate income, BKCC will employ a dynamic covered call option writing program. BCKL will invest entirely in BKCC, and then use cash-borrowing to enhance the exposure to BKCC by 1.25x.

MAGNIFYING PERFORMANCE WITH LIGHT LEVERAGE

With BKCL's 1.25x leverage, exposure to the performance of the Underlying ETF is magnified by 25% - resulting in potentially larger gains or losses relative to the Underlying ETF.
